

Next Level Athlete Waiver and Cage Rules

In consideration of the permission granted to me/my child/ward to participate in the activities of the Next Level Athlete LLC, I individually or as a parent/guardian hereby release, covenant not to sue and forever discharge Next Level Athlete, its officers, employees, agents and coaches from any and all claims of liabilities with regard to my participation in any clinics/camps/seminars or batting in cages. I (individually or as a parent/guardian) further state and certify that I am able to participate in the described activities of the clinics/camps/seminars or batting in cages. I/my child/ward further agree that should I/my child/ward become injured as a result of participation that I/my child/ward do release and hold harmless the Next Level Athlete LLC, its officers, employees, agents and coaches from any and all liability for illness, injury, disability, death or loss or damage to person or property and any consequences thereto and therefrom. This release shall inure to the benefit of the Next Level Athlete, its officers, employees, agents and coaches and shall be binding on my heir, successors and executors. I/my child/ward further state that the Next Level Athlete LLC, are authorized to use my/my child/ward's name and any photographs or videotape of me/my child/ward at the facility for its promotional purposes without the need to compensate me for such use.

I, (individually or as a parent/guardian) have read this liability form and have been given sufficient time to review it and ask whatever questions I have relating to it. I fully understand the risks involved and that it is possible to sustain serious injury or death during the course of participating in the above described activities. I, (individually or as a parent/guardian) acknowledge that my execution hereof is material to acceptance of my participation in clinics/camps/seminars or batting in cages. I have given up substantial rights by signing this agreement and I have freely and voluntarily agreed to sign without inducement. Furthermore, by signing below, I agree that in case of accident while at a clinic/camp, I authorize the Next Level Athlete LLC staff to act for me in securing medical treatment, and I release Next Level Athlete LLC and its officers and staff of any liability.

- 1) Participants must have a helmet on at all times.
- 2) All pitchers/coaches throwing to batters must stay behind protective screens.
- 3) All non-participating members of camps/clinics/lessons/practices/batting in cages will wait outside the cage behind the protective fence.
- 4) No more than 4 participants are allowed in the cage at one time.
- 5) No drinks/gum/food allowed in the cages at any time.
- 6) When splitting a cage, participants must hit in opposite directions.
- 7) No additional equipment may be added to a cage without approval of Next Level Athlete Staff.
- 8) The use of any cage must be assigned by NLA Staff prior to use.
- 9) Immediately notify Next Level Athlete Staff regarding any equipment, safety hazards, or unsafe conditions that may exist.
- 10) Activity must cease 5 minutes prior to scheduled finish time in order to clean up and return the cage to its original condition.
